## Commission against trafficking in human beings

In our commission we deal with the sex industry and its connections with organised crime

Our priorities are to:

- É Identify the traffickers and the victims
- É Conduct sound investigations
- É Put the suspects on trial
- É Get convictions



## Commission against trafficking in human beings

Method:

- É Pre-surveillance
- É Surveillance
- É Investigation
- É The investigation ready for the prosecutor



## Commission against trafficking in human beings

Personnel:

- É Indoor surveillance (3)
- É Outdoor surveillance (12 up to 18)
- É Investigation group (10)
- É Management (2)
- É Personnel from the social security (1)
- É Administration (1)



## Commission against trafficking in human beings

Legislation:

- É Purchase of sexual services, day fine up to six months in prison
- É Procuring (pimping), 14 days up to four years in prison
- É Gross procuring, 2 years up to 8 years in prison
- É Trafficking for human beings 2 years up to 10 years in prison



## Commission against trafficking in human beings

Customer:

- É out of 14 (1 out of 8, during the 90's) in Sweden at least once in their lives
- É Married, all age groups, social classes
- É Problem with themselves
- É Having power
- É A sponsor of organised crime

## Commission against trafficking in human beings

The organisers:

- É Using the girls dysfunctional background
- É An invisible prison
- É Psychopaths
- É Multicriminals
- É Best profit to the lowest risk



## Commission against trafficking in human beings

The woman:

- É Difficult backgrounds
- É Victims of sexual abuse
- É Not voluntarily
- É Prostitution = Trafficking



## Commission against trafficking in human beings

- É Don't know how they will be treated
- É How many customers they need to have
- É That they can't choose their customers
- É Going back whenever they want to
- É How much money
- É Giving sex
- É Raped



## Commission against trafficking in human beings

Co-operation:

- É With different parts in the police
- É With the prosecutors
- É With the social service
- É With other public authorities
- É With NGO-s



## Commission against trafficking in human beings

Streetprostitution vs Internetprostitution?

- É Most activities on Internet
- É Streetprostitution still in Stockholm
- É A decreasing comparing 10 years ago
- É Internetprostitution is not a consequence of the Swedish legislation against sexual purchases



## Commission against trafficking in human beings

Final conclusions:

- É It's possible to fight against THB
- É Start with the buyers
- É Prostitution and THB is one part of organised, international crime
- É No one goes in to prostitution voluntary, it's a modern form of slavery
